If you currently hold a FnF Fuels fuel card, you will not be required to fill out another application form, simply complete a Terms of Credit form. Note there is not one card for all three fuel providers. FnF Fuels will issue individual cards for Mobil, Caltex and/or BP as required. If you wish to maintain the existing facility with Mobil only, no action is necessary.

2. Accounting Standards commencement date

Further to my February newsletter, the commencement of new PBE statutory accounting standards is 1 April 2015. As this falls in the middle of the financial year of most churches (30 June), the standards will not have to commence for churches until the report relating to the balance date 30 June 2016.

I am still working on a communication of the accounting standards templates, guidelines training and support tools available to churches and will advise accordingly.
