WHAT IS THE PURPOSE OF THIS UPDATE?


DESCRIPTION OF THIS FUND

The Balanced option invests in a wide range of assets. This option may be suitable for investors who want a diversified investment with exposure to shares and real assets, who are comfortable with greater fluctuations in the value of their retirement savings than can be expected from the Conservative option and who want to invest for the long term.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Balanced option:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.




EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Michael had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Michael received a return after fund charges were deducted of \$885.00 (that is 8.85% of his initial \$10,000). No other charges were deducted. This gives Michael a total return after tax of \$885.00 for the year.
