VACANCY: ECUMENICAL ENABLER FOR GENDER JUSTICE

Location: Pacific Conference of Churches Secretariat, Suva with limited travel in Fiji and the Pacific region.

General duties:

- Action the Safe Churches EVAWG strategy, implementation plan and timeline of activities
- Support PCC's member churches and National Council of Churches to actively engage in the local and national activities that contribute to ending violence against women and girls.
- Explore the climate –GBV nexus and disseminate information to MCs and NCCs.
- Support online consultations, webinar/trainings, and meetings with civil society stakeholders in country, regionally and beyond.
- Identify and approach potential partners and collaborators that will expand PCC's position and specific area of interest of MCs and NCCs.
- Prepare and disseminate updates on ESCJ activities, negotiation status and outcomes of PCC's engagement with other Ecumenical partners, CSOs and governments.
- Support MCs and NCCs to work alongside and engage with regional partners and key governments agencies.
- Coordinate participation of MCs and NCCs in regional and international climate events and meetings.
- Support and strengthen the PCC's network and its members
- Undertake other duties as required

Professional Attributes:

- Facilitative, flexible and collaborative.
- Ability to be creative, think analytically and be proactive.
- Ability to work autonomously as well as a member of a team.
- High levels of self-awareness, including confidence in managing competing agendas with a problem-solving approach.
- Understanding and commitment to PCC's vision, mission, principles and objectives.
- High level interpersonal and facilitation skills.
- Excellent written and verbal communications skills including cross cultural communication.
- Demonstrated analytical and conceptual thinking skills.
- Well-developed understanding of gender and multicultural issues.
- A living Christian faith and commitment to abide by PCC's code of conduct and other safeguarding policies
- A commitment to ecumenism, to working with people from other Christian denominations
- The ability to work under pressure

Required Knowledge and Experience:

- Working towards or completed a university degree, with courses in a subject related to Gender justice or equivalent qualification is desirable;

- Experience working with diverse partners and/or as part of an alliance, coalition or network in the Pacific region.
- At least 2 years of experience working on issues related to climate change in the Pacific Islands, with a working knowledge of Pacific regional and international climate change policy and structures.
- Experience in developing and implementing awareness, advocacy and communications.
- Ability to travel- Some domestic (regional/international) travel may be required during the contract period, subject to funding. It is a condition of the contract that staff abide by best practice security and safety protocols, policies and procedures.
